## General Festival Rules, Regulations and Specifications for Vendors

- 1. Applications will be accepted after April 1, 2017.
- 2. Payment **must** be included with application to reserve booth space(s). Booths will not be reserved without payment in full.
- 3. Vendor space is assigned on a first come, first serve basis. Downtown Poplar Bluff, Inc. (DPB) will make every effort to assign vendors to their preferred location; however, we reserve the right to place vendors where space is available.
- 4. Returning vendors have until June 16, 2017, to reserve their booths from the previous year or they will be released.
- 5. New vendors must submit photos of their booth/vendor trailer with their application.
- 6. All booth spaces are 10'x 20'. This space includes trailer tongues, axles, anchors and legs of canopies. If your measurement **exceeds** 10'x 20', please reserve an additional booth space. Vendors may **NOT** secure canopies by drilling or hammering into the street or sidewalk. Please be prepared to anchor your canopy. The sidewalks may not be used for storage or blocked in any way.
- 7. Tent, tables and direct water hookups are not provided.
- 8. All vendors must include a list of items to be sold with this application.
- 9. All applicants who were not vendors for the 2016 Iron Horse Festival must include photos of your booth and items available for sale (providing a website is permitted). Applications without this will not be considered.
- 10. The Festival is an outdoor event on streets which may be sloped or uneven. The event will proceed, rain or shine. Vendors are responsible for their own booth's rain protection and are expected to secure their own booth(s). If weather becomes too severe, DPB will make the final determination. NO REFUNDS will be given for any reason.
- 11. DPB reserves the final and absolute right to interpret rules and regulations and to settle and determine all matters, questions or differences in regard thereto, or otherwise arising out of, connected with, or incidental to the Iron Horse Festival.
- 12. Vendors are responsible for collecting & reporting sales tax on all transactions.

## **Banned Items**

- 1. Dangerous, offensive or obscene materials including literature, t-shirts, shirts, hats, caps and flags or the like. "Obscene" is defined as vulgar or sexually explicit language including curse words, nudity, partial nudity, or the like
- 2. Yard Sale/Flea Market items.
- 3. Snap pops or any other item containing explosive materials.
- 4. Knives, air guns, BB guns, pellet guns, etc.
- 5. Downtown Poplar Bluff, Inc. (DPB) reserves the right to inspect your booth space for banned items. If present, DPB will ask you to remove banned items. If you choose not to comply, your booth will be closed and you will be escorted from the festival immediately.
